The ideal candidate will be responsible for developing and implementing a long-term IT strategy, overseeing cybersecurity compliance with the company's telemetry-based hardware solutions, ensuring SOX compliance, developing SOPs and work instructions, supporting audits, conducting evaluations and documenting validation testing for software rollouts and fostering a productive partnership with external IT partners. This person will be responsible for ensuring public company ITGC compliance.

Aerin's existing technology environment consists primarily of Cloud-based Enterprise solutions (e.g., Netsuite, Salesforce.com, Simploud, Adaptive Insights, etc.) run on a Microsoft technology stack (Microsoft Azure Active Directory, Microsoft Exchange Server, Microsoft Defender, etc.). The company currently utilizes an Austin-based external IT service provider which provides help desk support, network configuration & security and other ancillary support services. This role will initially manage Aerin's external IT service provider with the potential to build out an internal team in the future.

- Partner with Aerin's engineering team to safeguard sensitive data on the company's next-generation RF consoles and other hardware solutions employing telemetry capabilities, while ensuring compliance with industry cybersecurity standards.
